Evaluation criteria and requirements for individuals who expressed their wish to participate in the competitive selection of independent members of the Supervisory Board of the state enterprise 'Medical Procurement of Ukraine'

In accordance with the principles governing the establishment of the Supervisory Board of SE 'Medical Procurement of Ukraine', a candidate for the position of an independent member of the Supervisory Board shall meet the following requirements:

have higher education in the field of expertise, as follows: health or management and administration, or finance, or economics, or auditing, or banking, or manufacturing and technology, or international relations, or law;

have previous service experience in managerial positions for at least five years, or civil service or equivalent service for at least five years;

have knowledge in public procurement, trends and prospects for the development of the industry, legislation;

possessing full civil capacity;

no possession of unspent convictions, no administrative penalties for committing an offense related to corruption;

not to hold elected positions and not to be officials of state authorities and/or local self-governments;

be free from any material interests or relations with the Enterprise, its management, which may jeopardize the adoption of an objective decision.

have an impeccable business reputation;

adhere to the principles of impartiality and integrity, develop and update their knowledge and skills.

A member of the Supervisory Board shall meet the requirements established by the Law of Ukraine 'On Management of Objects of State-Owned Property' and the Enterprise Charter throughout the term of office as a member of the Supervisory Board of the Enterprise.

An independent member of the Supervisory Board of the Enterprise shall additionally meet the requirements for an independent member of the Supervisory Board of a state unitary enterprise and business company, the authorized capital of which more than 50 percent of shares (stakes) belongs to the state, approved by the Cabinet of Ministers of Ukraine.

Expected functions of independent members of the Supervisory Board of SE 'Medical Procurement of Ukraine':

constructive and critical evaluation of proposals on the Enterprise strategy; exercising control over reporting on the Enterprise management performance results;
